Rice Division Newsletter 2017

Update from the Division

As of Oct. 13, 2016, our division has a total of 47 members, with two new members joined in early 2016. Currently, our division has only 10 student members, suggesting that we should welcome more students to join our division.

During the last AACCI annual meeting held on Oct. 23-26, 2016, in Savannah, GA, we had a successful division luncheon meeting on Oct. 24, 2016. Division chair Jinsong Bao presided at the meeting, Dr. Rusty Bautista (DLC representative) introduced the past activities, Jinsong Bao also reported the financial status of our division. Then, division members elected Mr. John Ashby as new division vice chair. Prof. Ya-jane Wang and Dr. Rusty Bautista introduced the new plan of a rice chemistry and technology short course which will be held in the University of Arkansas Food Science Department next year (2017). Finally, Dr. Francesco Dell'endice (Qualysense, Switzerland) gave a short presentation on the high speed/high throughput grain quality instrument, and Dr. Mark Bason (Perten Instrument) provided an update on the development of Paddycheck and its application in rice quality assessments. A total of 20 members attended the division meeting.

In January, a Division Leadership Council (*DLC*) meeting took place at AACC International headquarters, focusing on the accomplishments and status on action plan of the DLC and each division from this past year. The vice chair John Ashby represented the Rice Division. The AACCI Chair of the Board Lydia Midness along with President-Elect Laura Hansen attended the meeting. The AACCI Scientific Advisory Panel (SAP) reported the top science areas for AACCI focus for the Board, and previewed their findings to help inform our discussions and action plan. Some divisions presented their past activities and potential new division activities as well collaborations between the divisions. John introduced that our division has a plan to hold rice milling quality short course in the University of Arkansas.

The first rice milling quality short course was held on May 22, 2017 at the Food Science Department, University of Arkansas and was a big success! This short course is designed for rice processors, food scientists, and technologists who wish to learn rice milling and its impact on rice properties in food product development. A total of 25 registrants/attendees from private industry, academia, and research institutions attended the one-day course. Dr. Jarrod Hardke gave a lecture on "rice as a food

grain", Dr. Terry Siebenmorgen provided two lectures on rice milling, and Dr. Ya Jane Wang shared her expertise on rice kernel composition and chemistry. Kimberly Batham from AACCI and Robin January of the University of Arkansas did a phenomenal job in coordinating/organizing the event. Drs. Terry Siebenmorgen and Ya-Jane Wang's leadership on this program were top notch! We are grateful for their great contributions!

With the success of the rice milling quality short course, which was produced as a component of the AACCI Continuing Education Department, the AACCI and the Rice Division is currently planning and coordinating with the Rice Processing Program/Food Science Department of the University of Arkansas to offer the course in 2018. This cooperative program, however, will be promoted as an AACCI Rice Division course and any gain associated with the course will benefit the division. More updates to come at the division meeting in San Diego. An equally successful short course next year would mean potential additional income for the division.

To strengthen our division's opportunity to sponsor a symposium, we encourage every member to prepare potential symposium proposals as soon as possible after the annual meeting. All division members are encouraged to submit proposals. Five speakers should be invited for each symposium. If anyone has an idea for symposium you may email to all other members for discussion and selection of speakers.
